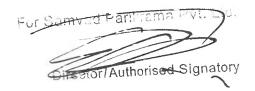

- I. The Name of the Company is SAMVAD PARIKARMA PRIVATE LIMITED.
- II. The Registered Office of the Company will be situated in the National Capital Territory of Delhi.
- III. The objects for which the Company is established are :-
- (A) THE MAIN OBJECTS TO BE PURSUED BY THE COMPANY ON ITS INCORPORATION ARE :-
- To run a news or Feature Agency for the print Media.
- To carry on the business as Proprietor and publisher of News Feature and Communication Services, News Papers, Periodicals and such other Print Media related works and undertaking of all such types.
- To carry on the business of public relation and advertising agency.
- 4. To run Printing and Composing unit.
- 5. To own wholly the business Samvad Parikrama, a proprietary concern.
- To make, produce, edit, direct, finance, distribute and make copies of Feature and Video Films and to record, distribute and market audio and video tapes and allied equipment.
- To undertake assignments through public relations and Newspapers to make feature, documentary and Advertisement films, still and slide projection and Audio Visual Displays.



- 7. To apply for and obtain any order of Central/State or other Authority for enabling the Company to carry on any of its objects into effect or for effecting any modifications of the Company's constitution or any other such purpose, which may seem expedient and to make representations against any proceedings or applications which may seem calculated directly or indirectly to prejudice the Company's interests.
- 8. To enter into partnerships or into any arrangement for sharing profits, union of interests, co-operation, joint-venture, reciprocal concessions or otherwise with any person, firm or company carrying on or engaged in any business of transaction which this Company is authorised to carry on and subject to section 391 to 394 of the companies Act, 1956 to amalgamate with any other such Company, having main objects altogether or in part similar to those of this Company.

#### (THE COMPANIES ACT, 1956) (COMPANY LIMITED BY SHARES) ARTICLES OF ASSOCIATION

OF

#### SAMVAD PARIKARMA PRIVATE LIMITED

#### I. PRELIMINARY

1. The Regulations contained in Table 'A' in the Schedule I to the Companies Act, 1956, shall apply to the Company except in as far as otherwise expressly incorporated hereinafter.

#### II. INTERPRETATION

- 2. (i) In these Regulations:-
  - (a) 'The Act' means the Companies Act, 1956, as amended, from time to time.
  - (b) 'The Seal' means the Common Seal of the Company.
  - (ii) Unless the context otherwise requires, words or expressions contained in these Regulations shall bear the same meaning as in the Act or any Statutory modification thereof in force.

#### III. PRIVATE CCMPANY

- 3. The Company is a Private Company within the meaning of Section 2(35) and 3 (1) (iii) of the Companies Act, 1956 and accordingly:-
  - (a) No invitation shall be issued to the public to subscribe for any shares in, or debentures, of the Company.
  - (b) The number of members of the Company (exclusive of persons who are in the employment of the Company and persons who, having been formerly in the employment of the Company, were members of the Company while in that employment and have continued to be members after the employment ceased) is limited to fifty, provided that for the purpose of this definition, where two or more persons jointly hold one or more shares in the Company, they shall be treated as a single member and;
  - (c) The right to transfer the shares in the Company is restricted in the manner and to the extent hereinafter appearing.
  - (d) Prohibits any invention or acceptance of deposits from persons other than its members, directors or their relatives.

#### IV. CAPITAL

4. The Authorised Share Capital of the Company is as mentioned in Clause V of the Memorandum of Association of the Company with power of the Board of Directors to sub-divide, consolidate and increase and with power from time to time, issue any shares of the original capital with and subject to any preferential, qualified or



notice than of seven days if consent thereto is given by member in accordance with the provisions of Section 171 of the Companies Act, 1956.

#### VII. PROCEEDINGS AT GENERAL MEETING

- 12. (i) No business shall be transacted at any General Meeting unless a specified quorum of members is present at the time when the meeting proceeds to transact business.
  - (ii) two members present in person shall be a quorum.
- 13. The Chairman, if any, of the shall preside as Chairman at every General Meeting of the Company.
- 14. If there is no such Chairman or if he is not present within fifteen minutes after the time appointed for holding the meeting or is unwilling to act as Chairman of the meeting, the Directors present shall elect one of their members to be Chairman of the meeting.
- 15. If at any meeting no Director is willing to act as Chairman or if no Director is present within 15 (Fifteen) minutes after the time appointed for holding the meeting, the members present shall choose one of their members to be Chairman of the meeting.
- 16. (i) The Chairman may, with the consent of any meeting at which a quorum is present and shall, if so directed by the meeting, adjourn the meetings, from time to time and from place to place.
  - (ii) No business shall be transacted at any adjourned meeting other than the business left unfinished at the meeting from which the adjournment took place.
  - (iii) When the meeting is adjourned for thirty days or more, notice of the adjourned meeting shall be given as in the case of an original meeting.
  - (iv) Save as aforesaid, it shall not be necessary to give any notice of an adjournment or of the business to be transacted at the adjourned meeting
- 17. In case of equality of votes, whether on a show of hands or on a poll, the Chairman of the meeting at which the show of hands takes place or at which the poll is demanded, shall be entitled to a second or casting vote.
- 18. Any business other than that upon which a poll has been demanded may be proceeded with, pending the taking of the poll.

#### VIII. DIRECTORS

19. The business of the Company shall be managed by the Directors who may pay all expenses incurred in setting up and registered the Company and may exercise all such powers of the Company as are not restricted by the Act or any statutory modification thereof for the time being in force or by these Articles required to be exercised by the Company in general meeting, subject nevertheless, to any regulations of these Articles, to the provision of the Act, and to such regulation not being inconsistent with the aforesaid regulations or provisions as may be prescribed by the Company in general meeting. Nothing shall invalidate any prior



- 28. The Directors may appoint any person to be an alternate Director to act for a Director (hereinafter in this Article called the original Director) during his absence for a period not less than three months from the State in which meetings of the Directors are ordinarily held, but such alternate Director shall, *ipso facto* vacate office if and when the original Director returns to the State in which the meetings of the Directors are ordinarily held, subject to Section 313 of the Act.
- 29. The Directors shall not be liable to retire from the office by rotation.
- 30. The Board of Director may, from time to time, by ordinary resolution increase or reduce the number of Directors within the limits specified in Article 21.
- 31. The Director shall have the power, at any time and from time to time, to appoint any person as Director in addition to the existing Directors so that the total number of Directors shall not at any time exceed the number fixed for Directors in these Articles. Any Director so appointed shall hold office only until the next following Annual General Meeting, but shall be eligible thereat for election as Director.
- 32. The Company, may by ordinary resolution, of which special notice has been given in accordance with the provisions of the Section 190 of the Companies Act, 1956 remove any Director including the Managing Director, if any, before the expiration of the period of his office, notwithstanding anything contained in these regulations or in any agreement between the Company and such Director, Such removal shall be without prejudice to any contract of service between him and the Company.
- 33. If the Director appointed by the Company in general meeting, vacates office as a Director before his term of office would expire in the normal course, the resulting casual vacancy may be filled up by the Board of Directors at a meeting of the Board but any person so appointed shall retain his office so long only as the vacating Director would have retained the same if vacancy had not occurred provided that the Board of Directors may not fill such a vacancy by appointing thereto any person who has been removed from the office of Director under Article 32.
- 34. In the event of the Company borrowing any money from any financial corporation or institution or Government or any Government body or a collaborator, bank person or persons or from any other source, while any money remains due to them or any of them, the lender concerned may have and may exercise the right and power to appoint from time to time, any person or persons to be a Director or Directors of the Company and the Directors so appointed shall not be liable to retire by rotation, subject however, to the limits prescribed by the Companies Act, 1956. Any person so appointed may at any time be removed from the office by the appointing authority who may from time of such removal or in case of death resignation of person, appoint any other or others in his place. Any such appointment or removal shall be in writing, signed by the appointer and served on the Company. Such Director need not hold any qualification shares.
- 35. Section 283 of the Companies Act, 1956, shall apply, regarding vacation of office by Director. A Director shall also be entitled to resign from the office of Directors from such date as he may specify while so resigning.



debentures and any other powers which by reason of the provision of the Act cannot be delegated to Committees consisting of such member or members of their body as they may think fit and they may, from time to time, revoke and discharge any such Committee either wholly or in part and either as to persons or person. Every Committee so formed, in exercise of powers so delegated, shall conform to any regulations that may, from time to time, be imposed on it by the Directors and all acts done by any such Committee in conformity with such regulations and in fulfilment of the purpose of their appointment, but not otherwise shall have the like force and effect as if by the Board of Directors.

- 47. A resolution not being a resolution required by the Act or by these Articles to be passed at a meeting of the Directors, may be passed without the meeting of the Directors or a Committee of Directors, provided that the resolution has been circulated in the draft together with necessary papers, if any, to all the Directors or to all the members of the Committee then in India (not less than the quorum fixed for a meeting of the Board or Committee, as the case may be) and to all other Directors or members at their usual addresses in India, and has been approved by such of the Directors as then in India or by a majority of such of them as are entitled to vote on the resolution.
- 48. All acts done by a person shall be valid, notwithstanding that it may be afterwards discovered that his appointment was invalid by reason of any defect of disqualification or had terminated by virtue of any provisions contained in the said Act or in these Articles. Provided that this Article shall not give validity to acts done by a Director after his appointment has been shown to the Company to be invalid or to have terminated.

#### XI. POWERS OF THE DIRECTORS

- 49 Subject to Sections 292 of the Act, the Directors shall have the right to delegate any of their powers to such managers, agents or other persons as they may deem fit and may at their own discretion revoke such powers.
- The Directors shall have powers for the engagement and dismissal of managers, engineers, clerks and assistants and shall have power of general direction, management and superintendence of the business of the Company with full powers to do all such acts, matters and things deemed necessary, proper or expedient for carrying on the business of the Company, and to make and sign all such contracts and to draw and accept on behalf of the Company all such bills of exchange, hundies, cheques, drafts and other Government papers and instruments that shall be necessary, proper or expedient, for the authority and direction of the Company except only such of them as by the Act or by these presents are expressly directed to be exercised by share-holders in the general meeting.

#### XII. INSPECTION OF ACCOUNTS

- 51. (i) The Board of Directors shall cause proper books of account to be maintained under Section 209 of the Act, 1956.
  - (ii) Subject to the provisions of Section 209A of the Companies Act, 1956, the Board of Directors shall also, from time to time, determine whether and to what extent and at what times and places and under what conditions or



#### XVII. WINDING UP

- 56. (i) If the company shall be wound up, the liquidator may with the sanction of a special resolution of the Company and any other sanction required by the Act, divide amongst the members in specie or kind, the whole or any part of the assets of the Company, whether they shall consist of property of the same kind or not.
  - (ii) For the purpose aforesaid, the liquidator may set such value as he deems fair upon any property to be divided as aforesaid and may determine how such division shall be carried out as between the members or different classes of members.
  - (iii) The liquidator may, with the like sanction, vest the whole or any part of such assets in trustees upon such trusts for the benefit of the contributories as the liquidator shall think fit but so that no member shall be compelled to accept any shares or other securities whereon there is any liability.

#### XVIII. COMMON SEAL

- 57. (i) The Board shall provide for the safe custody of the seal of the Company.
  - (ii) The seal shall not be affixed to any instrument except by the authority of resolution of the Board or of a committee of the Board authorised by it in that behalf and except in the presence of at least one director and that one director shall sign every instrument to which the seal of the Company is so affixed in his presence. The share certificate will, however, be signed and sealed in accordance with Rule 6 of the Companies (Issue of Share Certificates) Rules, 1960.

#### XIX. BALANCE SHEET AND PROFIT AND LOSS ACCOUNT

56. Balance Sheet and Profit and Loss Account of the Company will be audited once in a year by a qualitied auditor for certification of correctness as per provisions of the Companies Act, 1956.

#### XIX. AUDIT

- 59. The first auditors of the Company shall be appointed by the Board of Directors within one month after its incorporation who shall hold office till the conclusion of first annual general meeting.
- 60. The Directors may fill up any casual vacancy in the office of the Auditors.
- 61. The remuneration of the Auditors shall be fixed by the Company in Annual general meeting except that remuneration of the first or any Auditors appointed by the directors may be fixed by the Board of Directors.
