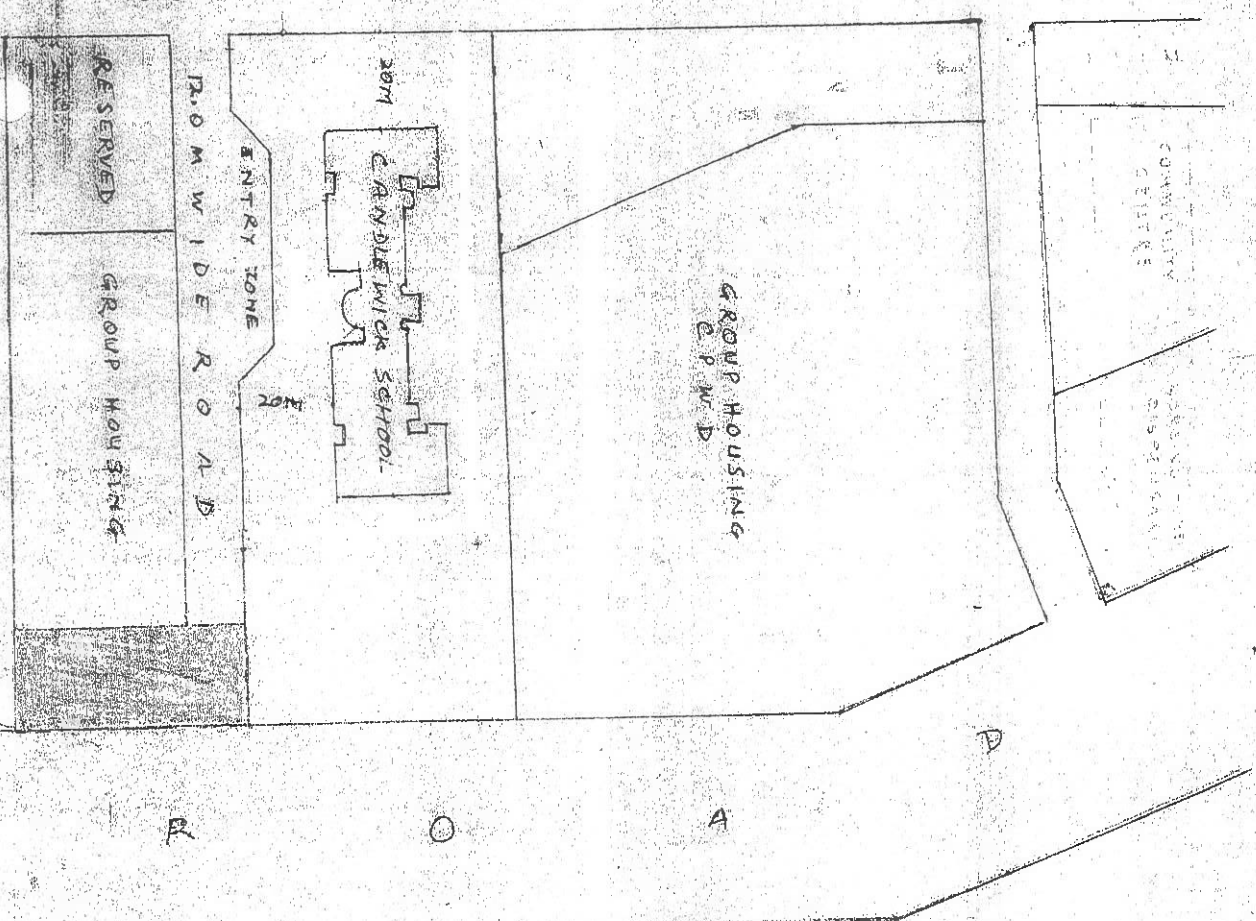
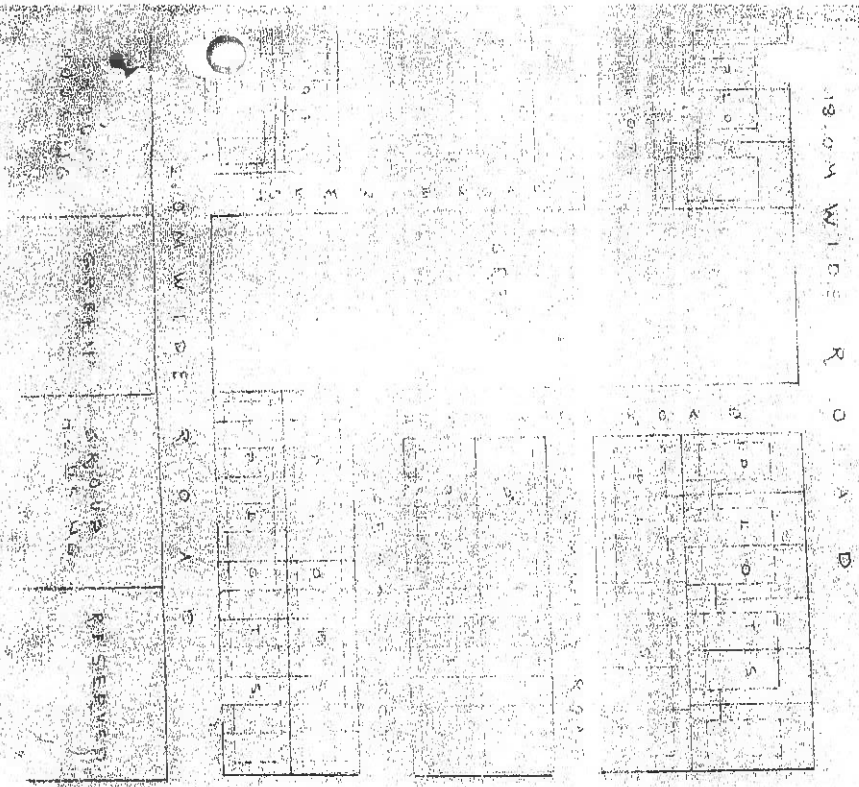

(MEMORANDUM OF ASSOCIATION)

1. Name of the Society : The name of the Society shall be "CANDLEWICK EDUCATIONAL SOCIETY" JAIPUR.
2. Registered Office : The Registered office of the Society is D-5, DHAPI BAI MARG, BANI PARK, JAIPUR-302016. The area of operation will be in and around JAIPUR CITY.
3. Objects of the Society : Following are the aims and objectives of the Society:-
  - (a) To provide quality education to the people through the medium of school(s) particularly CANDLEWICK PUBLIC SCHOOL JAIPUR, and by any other institution(s) or concern(s) that in time be opened now or later.
  - (b) To undertake any form of work that is directed towards the improvement, increase and spread of education which is for the benefit of the people and shall be open to all without any distinction of race, Caste/ or class and without any conditions being imposed as to religion or belief in matters of admissions to students or appointment of teachers/staffs.
  - (c) To Co-operate with educational or other institutions having objects wholly or partly similar to those of the Society by exchange of persons/teachers/scholars and generally in such a manner as may be conducive, to the common objects.
  - (d) To encourage and support such forms of special services as may properly be undertaken by the educational institutions. Medical relief and help to the poorer community.
  - (e) To Generally provide such training both mental and Physical to the students and others so as to make them worthy citizens of India.
  - (f) To employ and appoint agents for any of the stated purposes of the Society.
  - (g) To pay out of the funds of the society or out of any particular part of such funds expenses of and incidental to the formation and management of the Society including the payment of salaries to the the persons employed.
  - (h) To do all such lawful acts and things as are incidental to or conducive to the attainment of the above stated objects.
  - (i) There is no profit motive involved in attainment of the above objects.

4. Membership :

Persons with the following qualifications and requisites will be considered eligible to become members of the Society :

- (a) Mentally and financially sound adults.
- (b) Having faith and interest in the basic aims and objectives of the Society, and
- (c) Those who consider supreme the interest of the Society.

5. Class of Members :

Members of the Society shall be of the following two classes :-

- (a) Honorary Members : Individuals of eminence and social standing who may be nominated or invited by the governing body to become members of the Society.
- (b) Ordinary Members : Individuals who seek Membership through application provided they have been accepted to be ordinary members of the society by the governing body.

The governing body has complete and absolute powers to accept or refuse applications for membership and shall not be required to give any reasons for such decisions.

6. Subscription :

No subscription is payable members of the Society.

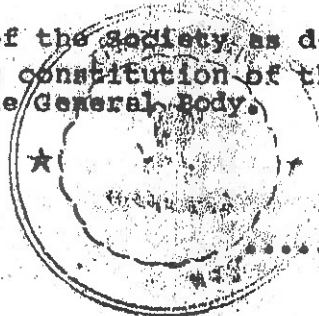
7. Removal from Membership :

An individual shall cease to be a member of the Society :

- (a) On his/her death.
- (b) On his/her resignation to be signified in writing.
- (c) On the passing of a Resolution by not less than two-third of the members present at a General-Body Meeting specially convened for the purpose that he/she should cease to be a member.

8. General Body :

All classes of members of the Society as defined in item number five of this constitution of the Society will jointly comprise the General Body.

9. Powers and Duties of the General Body :

The powers and duties of the General Body of the Society shall be as follows :

- (a) To elect the office bearers & members of the Governing body.
- (b) To pass the annual budget.
- (c) To assess and ratify the action of the governing body.
- (d) To amend, change or modify the constitutions of the Society by obtaining two-third majority of the total strength of the members present in a general body meeting specially convened for the purpose (This will be applicable after filing and obtaining a true copy of the same from the Registrar's Office).

10. Meeting of general body :

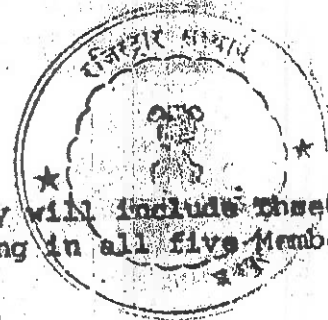
- (a) Ordinarily a general body meeting shall be held annually. However, in case of necessity special meetings may be called at any given time and place by the chairperson or Secretary of the Society.
- (b) The quorum of a general body of the Society shall consist of not less than one-third of the total membership of the Society.
- (c) Prior Notice for ordinary meetings shall be seven days and for emergency/special Meetings it shall be two days.
- (d) In the absence of a quorum the meeting shall be adjourned. The adjourned meeting can be called within seven days at any time and date. In an adjourned meeting a quorum is not required but only matters of the original agenda will be considered.

11. Governing Body :

For proper and effective functioning of the works and actions of the Society and its concerns, namely Candlewick Public School, Jaipur, a governing body is to be constituted which will have the following office bearers and Members :

- (a) Chairperson - one
- (b) Secretary - One
- (c) Treasurer - One
- (d) Members - One

Therefore, the governing body will include three office-bearers and two members, totalling in all five members.

12. Election of the governing body :

The election of the office-bearers and Members of the governing body shall be done by the general body and its tenure shall be of three years.

13. Powers and Duties of the Governing Body :

- (a) To make or remove members.
- (b) To prepare and approve the annual budget.
- (c) To fill any vacancy among members of the governing body including those of Office/bearers.
- (d) To acquire, protect and safeguard the movable and immovable properties of the Society and its concerns.
- (e) To appoint/dismiss and fix emoluments of all paid employees of the Society and its concerns.
- (f) To execute all decisions and resolutions of the society.
- (g) To form Committees, etc., for proper execution of the decisions of the Society.
- (h) To conduct all tasks which are in the interest of the Society and its concerns.

14. Meeting of the Governing Body :

- (a) The Governing Body shall meet at least four times in a Year. However, in case of necessity an emergency/special meeting can be called by the Chairperson of the Society.
- (b) The required quorum of the meeting of the Governing Body shall be more than half of the total strength of the members.
- (c) For meetings of the Governing Body generally seven days notice will be required. However, emergency/special meetings can be called at any time at short notice also.
- (d) In the absence of a quorum of the meeting shall be adjourned. The adjourned meeting may be called again, even the next day, at a suitable place and time. In the adjourned meeting a quorum is not necessary; however, only matters on the original agenda will be considered. In the adjourned meeting the presence of at least two office-bearers will be necessary. All decisions taken in the adjourned meeting will have to be ratified at the next meeting of the Governing body.

15. Powers and Duties of the office-bearers :

(a) Chairperson :

- i.) He/She is to Preside over all meetings of the Governing Body and Society, and at meeting of such other Committees of which he/she is a member.
- ii.) In case there is an equality of votes the Chairperson shall have a second or a casting vote.
- iii.) To call meetings of all bodies and Committees.
- iv.) To represent the Society.
- v.) To sign documents for and on behalf of the Society.

(b) Secretary :

- i.) To carry out Correspondence on behalf of the Society.
- ii.) To keep full and accurate record of minutes/Proceedings of the meetings of the Governing body and all other meetings of which he/she is an ex-office members.
- iii.) The Secretary shall have full powers to do the following when the governing body is not in session :
  - (aa) Authorise the payment of all expenses incurred in the management of the Society and its concerns in accordance with the provisions of the budget.
  - (bb) To appoint/dismiss sub. Committee(s) consisting of one or more members.
  - (cc) Take legal advice on any matter related to the welfare of the concern(s) and to act in accordance with such advice.
  - (dd) Appoint/suspend or dismiss such officers, teachers and office/ministerial staff as deemed necessary and to fix their duties and remuneration (and if considered necessary to require security)
  - (ee) The Secretary shall be the officer to execute and sign all legal documents for and on behalf of the Society and its concern(s).
  - (ff) The Secretary shall approve and grant leave of any kind to the principal of the School(s)/Institution(s).

15. (c) Treasurer :

- i) The Treasurer shall keep full and accurate accounts of all monies receive or spend by the Society and its concern(s).
- ii) Together with the Secretary or any other person authorised by the Governing Body the Treasurer shall deposit or withdraw monies from Bank(s) and shall sign all cheques.
- iii) The Treasurer shall ensure the correctness of the annual income and expenditure account of the school(s)/Institution(s) submitted by the principal(s) to the Governing Body.

(d) Principal(s) :

- i) The Principal of school(s)/Institution(s) shall be responsible for the successful and smooth day to day running of the School.
- ii) The Principal shall function with the administrative and financial powers determined and delegated to him/her now or later by the Governing Body.
- iii) The Principal Via a Via the school/Institution shall be responsible for :-
  - (aa) All Curricular, Co-curricular and extra-curricular activities.
  - (bb) Proper maintenance of all variety of the Institution/school records.
  - (cc) Recommend appointment, suspension, dismissal of officers, teachers, and office/ministrial staff of the Institution school.
  - (dd) Admission, transfers, promotions, expulsions etc...of students.
  - (ee) Granting of leave to students and staff.
  - (ff) Framing of annual report of school/Institution.
  - (gg) Casting of budget for the next session.
  - (hh) Any such act which is directly beneficial to the school/Institution.

16. Finances :

Funds will be generated through fees grants gifts and donations from individuals, institutions, Govt/Semi-Govt. Organisations, subsidies/Assistances/aids. All Funds received will be deposited in a Bank.

The Bank account(s) will be jointly operated by the person appointed

17. Special Financial Powers :

According to the need of the the situation and in the interest of the school(s) /Institution(s)/Society the following Financial Powers are to be exercised in matters involving expenses/disbursement of Funds :-

- (a) Chairperson : Amount: not exceeding Rs.5000/-at a given time.
- (b) Secretary : Amount: not exceeding Rs.3000/-at a given time.
- (c) Treasurer : Amount: not exceeding Rs.1000/-at a given time.
- (d) Principal : Amount: not exceeding Rs.500/-at a given time. (Five Hundred)

Expenditures required to be incurred beyond the Financial Powers of the Chairperson are to be referred to the Governing Body for approval.

18. Audit :

An auditor will be appointed by the Governing body to audit the annual income and expenditure account(s)-

19. Amendment of the Constitution :

As per need the constitution of the Society can be changed amended or modified by a two-third majority of the members present in a General Body Meeting in accordance with Rajasthan Registration of Societies Act., 1958, Clause 12.

20. Dissolution :

In case the Society is dissolved, then it will have the right to transfer its assets to an agency with similar aims and objectives. However, this action will be in accordance with the Rajasthan Registration of Societies Act 1958, Clauses 13 & 14.

21. Inspection of Records :

The Registrar Societies, Jaipur will have the right to inspection the records of the Society and the suggestions made will be complied with.
