

MANAGEMENT OF THE BOARD

The management of the board shall vest in Governing council which will consist of 13 elected and 4 coopted members (by the Governing Council) out of which minimum 2 shall be women. All the members shall be honorary. If any member is employed in the Board or in any Institutions, he shall cause to be a member of the Governing Council.

7. FOWERS OF THE GENERAL BODY

Powers and functions of the General body shall be as follows:
(a) To elect the President and members of the Governing Council

who shall be at least

- (b) To approve the annual report of the Board/Institutions.
- (c) To evulate the work of the Governing Council.
- (d) To ammond or change the constitution/Autes/Dya-laws by

 2/3 majority of the members present and toting. The amended

 implemented after it is approved and a certified copy of
 the same is obtained.

MEETING OF THE GENERAL BODY

The meeting of the General body shall be held atleast once a year or as and when deemed necessary. An urgent meeting of the General body can be convened by the President of the Board whenever necessary or on the written requisition of members within a span of one menth compulsorily.

(11) A quoram of the meeting of the General body shall be 1/5 of the total membership on roll 1/4 members whichever is less.

- (111) A notice of the meeting shall be issued atleast 10 days before the date of the meeting. Extraordinary meeting can be convened on 5 days notice.
- (iv) Notice of the meeting shall be sent under U.P.C.
- (v) The mosting of the General body shall be adjourned in the absence of quorum and adjourned meeting may be reconvened after one hour at the same place. In such an event there will be no necessity of a quorum but the agenda for discussion will be the same as per previous agenda.

9. VOTING
