





In pursuance of the objectives and the aims enshrined in the Pitambra Maai Sewa Sansthan (Trust) Jaipur and of all other power enabling it in this behalf the Board of Trustees, hereby makes the following regulations to govern the proceeding and the conduct of business of the meeting of the Executive Committee as follows, namely:

Chapter-1

General

- 1. Short title: These regulations may be called the "Pitambra Maai Sewa Sansthan" Bylaws and Regulations, 2020.
- 2. Definitions: In these regulations, unless there is anything repugnant in the subject or context
- (a) "Trust" or "Sansthan" means the Pitambra Maai Sewa Sansthan.
- (b) "Committee" means the Executive Committee constituted under the Trust.
- (c) "Executive Officer" means the person authorised by the Executive Committee and appointed under the Trust.
- 3. Extent of application: Except as otherwise provided by or under these regulations, these regulations shall apply to all Trustees, members, Employees, Volunteers and persons appointed to the sansthan service, posts in connection with the affairs of the sansthan Trust to the extent of their contribution and role in conduct of business of the trust.
- 4. Power of interpretation: If any question arises relating to these regulations, it shall be referred to the Board of Trustees whose decision thereon shall be final.
- 5. Power of relaxation: Where the Board of Trustees is satisfied that the operation of any of these regulations causes or is likely to cause undue hardship in the case of any sansthan employee or class of employee, members, volunteers from any provisions of these regulations or may direct that such provisions of these regulations may direct that such provisions shall apply to such persons with modifications not affecting the substance thereof as may be specified in such resolution.

6. Exercise of delegation of powers under these regulations: It shall be open to the executive committee to specify, by general or special order, that powers under these regulations may be exercised or delegated to the executive officer or any other officer of the sansthan,

7. - 8. Notice of meeting: '(a) At least seven clear days* (excluding the date of service and the date of meeting) notice shall ordinarily be given of every meeting, other than special meeting. (b)If any member proposes to bring forward any business, other than that communicated along with the notice, he shall be at liberty to do so by written notice handed over to the Executive Officer before the commencement of the meeting.
- (c)If during a meeting, a member desires to bring forward any business, not included in the notice, he shall be permitted to do so only on the consent of the President.
- 9. Contents of notice and mode of service: Notice of the meeting specifying the day, time and place together with the business to be transacted there at shall be delivered to the member, in person or sent by registered post, express courier, fax or e-mail or any other mode of electronic communication under the signature, wherever possible of the Executive Officer at the address, fax number or e-mail address given by the member.
- 10. Manner of voting: If, on any proposition the members are divided, on demand by any member, the Presiding Authority shall put the proposition to vote which shall be by show of hands.
- (b) Every proposal before a meeting shall be decided by a majority of votes of the members present. The Presiding Authority shall have no vote. If there is equality of votes, the Presiding Authority will have a casting vote.
- 11. Resolutions: When the presiding authority declares that the proposition has been carried, a note to that effect shall be made in the minutes of the meeting, which shall be conclusive evidence of the fact.
- 12. Adjournment of meeting: If majority of the members present so decide, the meeting may be adjourned to a subsequent date and time when the unfinished business of the meeting shall be transacted.
- 13. Minutes of the meeting: The minutes, recorded in English, which may be translated into Hindi if required, shall be kept by the Secretary of the Committee. The names of the members present and the minutes shall be kept in the proceeding book which shall be signed at the end by the Executive Officer and the presiding authority, before the next ensuing meeting.
- 14. The suggestions, recommendations or proposals received from any member of Trust regarding festivals, ceremonies or poojas shall be scrutinized by the Executive Committee and it shall submit the same with his opinion thereon to the Executive Committee for consideration
- 15. Presiding Authority: Every meeting shall be presided over by the Managing Trustee and all INDIA in his absence by the President as presiding authority by the members from amongst themselves.

Chapter-2

Sub-Committee, Expert members & Consultants

- 1. Formation of Sub-Committee: The Executive Committee, as and when it deems necessary, may, for the purposes of proper management, maintenance and administration of properties and affairs of the trust constitute a sub-committee or sub-committees to decide and execute on such matters as may be assigned for; provided that the decisions of the sub-committee(s) shall be finalized only after the confirmation and approval by the executive committee.
- 2. In case of Mis-utilisation of the financial grants and, or financial arrangement made by the sub-committee appointed, it shall forthwith report it to the executive committee and executive committee shall give appropriate directions to executive officer to initiate necessary disciplinary and penal actions.
- 3. Expert members of the sub-committee who are not the members of the executive committee shall be paid sitting fees, travelling and daily allowances as may be fixed by the executive committee, from time to time. However, such members shall be free to waive off their right to claim their allowances terming it voluntary service to the trust.
- 4. Termination of Sub-committee: The executive shall always be empowered to cancel or terminate the sub-committee after giving one day's notice followed by reasoned statement in writing if feels sub-committee is not adhering to agenda or purpose of their formation or has acted beyond scope of their power.
- 5. Appointment of experts or consultants: (a) The Executive committee may, for the purpose of scrutiny of applications for financial aids, monitoring utilization of grant, donations, foreign contributions, legal advice may take assistance of a Chartered Accountant, Chartered Engineers, Lawyers or any other expert or consultant as required to be appointed by the trust in scrutiny committee or advisory committee.

(b) the honorarium and allowances of the experts or consultants shall be decided by the executive committee.

Chapter-3 Membership

1. Types of membership and subscription prescribed: The rate of membership for each type of membership shall be as follows:

(a)Patron Member

: Rs. 50000 (5 Locs)/- in lump sum (for period of 20 years)
: Rs. 3,50,000 (3.5 Locs)- in lump sum (for a period of 10 years)

(b)Life Member

(c)Ordinary Member: Rs.1,100/- (for a period 1 year)

- 2. Membership application: A person desirous of being a member of Trust shall apply to the Executive Committee in the prescribed form appended to these regulations. Any individual subscribing to the objectives of the Trust may become a member subject to the approval of the Board of Trustees, having good character as defined by normal social and ethical standards. Membership of the trust shall be based on need basis, individual commitment and faith in purpose of said Trust subject to approval of the board of trustees.
- 3. Honorary membership: shall be limited to individuals such as scholars, spiritual and/or religious leaders and dignitaries. This exclusive honour shall be granted for a two year-term by the Board of Trustees at its discretion. Honorary members may be reappointed by the Board of Trustees.
- 4. Any individuals, organizations and other corporations may donate to the trust however, merely by donating such persons shall neither become the members of the trust and nor shall they any rights to exercise as members. Membership shall be granted only by the Board based on individual, organisation or corporate's credibility and eligibility as defined.
- 5. Individual membership shall consist of the member registered with the trust. The fees for the same will be Rs. 1100/- only per annum. It shall be paid in the April month annually. Proper record Shall be maintained by the secretary for the same. Waiving off the membership fees will not be done under any circumstances. Following will be applicable to the members.

(a) Membership shall be considered as a privilege for admission to and for the use of the

facilities of the trust for designated activities.

(b) Award of membership will not automatically mean trusteeship.

(c) For becoming a trustee, the procedure as laid down in these laws will be adhered to.

(d) For use of facilities of the trust, minimum Rs. 2100/- will be charged from every member.

- (e) However, the above clause shall not be applicable to the founder trustees for use and organising any activity on their own behalf.
- (t) If any person who is not member of the trust wishes to use trust facilities, he/she will be charged Rs. 5000/- only. He/she has to be active member of the trust for at least 6 months before using the facilities.
- (g) Any activity which is not part of the objective of the trust shall not be allowed for any trustee, member or any other person.
- (h) The decision of board of trustees shall be final in all such matters.
- (i) The facilities of the Temple/Trust shall be used for religious, spiritual, educational, health and cultural activities in accordance with the policy approved by the Board of Trustees from time to time for the usage of premises. For any other activity, a prior approval of the Board of Trustees would be required. However, no activity shall be permitted if it is against the Trust's interest, or if such activity would jeopardize the Trust's status as an exempt non-profit organization under the law.
- (j) Member or members may have full use of the facilities for private use, with prior permission of the Board/ Executive committee.
- (k) All activities organized by the Trust shall have the priority in the use of Trust's premises. In case of unforeseen circumstances and emergencies, the Board/Executive committee has the right to cancel and/or rearrange any reservations.
- (l) The Trust's facilities shall be made available by prior reservation on FIRST COME FIRST SERVED BASIS. A refundable deposit in an amount as determined by the Board/Executive Committee and approved by the Board of Trustees shall be paid in advance as security. Other charges as determined by the Executive Committee and approved by the Board of Trustees shall also be paid in advance.
- (m) Individual(s) making the reservation shall be liable to pay in full for any damage to or loss of Temple or other properties while in use, and caused by any of the participant(s),
- 6. The rights and privileges of members of Trust: The rights and privileges of member of trust as follows, namely: (a)Invitations of all kinds of Religious ceremonies, Pooja and Havan shall be extended to the members of Trust and the same shall be affixed at temple or sent via mode decided by the executive committee.

(b) Every member shall be entitled to receive the Prasad as arranged by the committee.

(c) All the rights and privileges of existing Patron and Life Members shall continue, as they result were entitled to before coming into force of these regulations.

- 8. Record of service and work contribution: A record of service shall be maintained in respect of each sansthan employee and volunteer in such firm as may be prescribed from time to time by the executive committee. Proper volumes of record and register shall be maintained in such form as required as per law and adopted and agreed the executive committee.
- 9. Reversion and Transfer: Employees of sansthan may be transferred, at any time, from one place to another and also from one section or department of sansthan to another at the discretion of executive committee. Reversion of employee shall be done as a measure of penalty under disciplinary actions.
- 10. Deductions: The committee shall be entitled to make deductions from the salary of a sansthan employee on account of any advance, fine or amount of loss or damage in accordance with provisions of these regulations or any statutory provisions applicable to such employee. The trust shall have right to create lien or charge over the members whose annual subscription has become due and shall have right to demand the same. Upon failure to receive such contributions as agreed by the member, its membership will stand cancelled automatically.
- 11. Labour and wage code: All the provisions concerning the applicability of labour and wage code shall be complied with in the capacity of employer towards employees. All such social benefit contributions shall be accordingly made as required. Volunteers and member of the trust does not qualify for such benefits.
- 12. Prohibition of Child Labour: Under no circumstances the sansthan shall employ or engage a child less than 14 years of age for any domestic work or as provided for under the local laws.

- 6. Purchase of resignation: Any sansthan employee, volunteer or member shall not enter into any pecuniary arrangement or otherwise for the resignation by one of any office held by him/her under sansthan for the benefit of any other person.
- 7. Private trade and employment: No sansthan employee shall, except with previous sanction of the executive committee, engage directly or indirectly in any trade or business or undertake any other employment with any person or organisation which is associated with the sansthan or has been providing services or materials or supplies etc., to the trust in any manner.
- 8. Vindication of acts and character of sansthan employee: No sansthan employee shall, except with the previous sanction of the committee, have recourse to any court or to the press for the vindication of any official acts which has been subject matter of adverse criticism or an attack of defamatory character.
- 9. Prevention of Sexual harassment at work place: No sansthan employee, volunteer or member shall indulge in any act of sexual harassment of any woman within any of the premises of the sansthan. All necessary steps to prevent sexual harassment shall be taken.
- 10. Disciplinary proceedings and Penalties: (a) The executive committee or any person empowered by it may institute a disciplinary proceedings against sansthan employee, volunteer or member, conduct an enquiry, receive reply from person so accused, collect such evidence as necessary in normal course, give its report to the executive committee with recommendation of such penalty as may deemed appropriate.

(b) If, it is found that the person so accused is liable for disciplinary action then penalty may be imposed against such person as deemed appropriate by the executive committee based on the facts and circumstance of the case.

Chapter-6 Financial Policy, Audit & Accounts, Donations

- 1. The Trust accounts: and other relevant records and shall be prepared annually and a receipt and payment account and list of assets and liabilities in such form as may be prescribed under accounting norms in consultation with a professional chartered accountant.
