Traffic from Sardar Patel Marg to Sahakar Marg is more than traffic from Bhawani Singh Road to Hawa Sadak but topography of site does not permit to construct flyover from Sardar Patel Marg to Sahakar Marg. 2. However to give relief to traffic from Bhawani Singh road to Civil lines, which contribute around 30% to 40% of total traffic of rotary extention of 22 Godown Bridge is necessary and traffic from Hawa Sadak to Bhawani Singh Road passes directly over the circle to and fro. At grade traffic can be regulated either by rotary or by 3.It is also directed that opinion from expert like MNIT, Jaipur or IITs is also propose to seek with regard to traffice circulation & overall planning. This is the only solution to be done to mitigate the traffic problem at the circle. After lot of discussion, A&F Sanction amounting to Rs. 37.01 Crore & GAD, was approved by the committee.
