The direction given in last PWC reg not taking up any new roadwork without drainage was amended that- Any road work shall be taken up with drainage as far as possible but in cases where there is no disposal drain or in outer areas, work can be taken up in public interest ensuring proper slope & camber and making provisions that water doesn't stagnate on road.

2. All Executive Engineers shall submit "action taken report" on the QC reports within 7 days, failing which disciplinary action shall be initiated by concerned Director.

3. Director (Engg-I) shall put up necessary orders to link QC results with payments of the works.

The meeting ended with the vote of thanks to the chair.
