- 76. Cleanliness being a major concern, the agency shall take up daily cleaning by brooming, washing, removal of hand bills etc. to maintain neat and clear structure.
- 77. The X.En incharge shall inspect the FOB regularly and issue notice if shortcoming found. The agency shall follow the instructions and in case of failure to do so a penalty of Rs. 20,000.00 shall be imposed. If still the instructions are not followed JDA shall be free to terminate the agreement and take over the entity. The agency shall not have any claim for the investment/ loss in case of such termination.
- 78. In case any damage occurs, during concession period/ due to accident, theft natural effects etc. the repairing shall be done in 7 days. And made good by the agency.
- 79. If any accident occurs, during concession priod, due to improper working of escalators, electrocution due to leakage of current etc. the losses/ damages occurred shall be payable by the agency.
- 80. The successful bidder should deposit performance security in the form of Bank Guarantee of Rs 30 lacs.
