Process for Participation & Depositing Payment Online

To participate in the bid, bidder has to be:

- $1. \quad \text{Registered on JDA website } \underline{www.jda.urban.rajasthan.gov.in} \text{ (by depositing Rs. 500.00 online, the validity and the property of t$ of which remains 3 (three) years).
- For participating in the Bid, the Bidder has to apply for this Bid and pay the Bid Document Fee, RISL Processing Fee and Bid Security Deposit, online only.

Methods for depositing on line amount
