NOTIFICATION

In exercise of the powers conferred by sub-section (1) of section 9 of the Rajasthan Stamp Act, 1998 (Act No. 14 of 1999), the State Government being of the opinion that it is expedient in the public interest so to do, hereby orders that stamp duty chargeable on every intermediary unregistered and unstamped instrument of transfer of immovable property executed after allotment/sale by Jaipur Development Authority, lodhpur Development Authority, Rajasthan Housing Board, Urban Improvement Trust, Municipal Corporation, Municipal Council or Municipal Board, shall be reduced and charged on amount of original allotment instead of market value of the property, on the following conditions that:-

- (I) the leaseholder along with his lease deed shall submit a certificate before the Registering Officer issued by any of the above mentioned local authority stating therein the amount of original allotment; the number of intermediary unregistered and unstamped instruments executed in respect of the immovable property;
- (2) the Registering Officer shall ensure payment of above reduced stamp duty on every such intermediary unregistered and unstamped instrument before registering the lease deed; and
- (3) on the basis of such intermediary unregistered and unstamped instrument the lease deed shall be executed and submitted for registration up to 30.9.2013.
