NOTIFICATION

In exercise of the powers conferred by sub-section (1) and clause (i) of sub-section (2) of section 85 of the Real Estate (Regulation and Development) Act, 2016 (Central Act No. 16 of 2016), the Rajasthan Real Estate Regulatory Authority, having considered it necessary to do so, hereby makes the following regulations, to amend the Rajasthan Real Estate Regulatory Authority Regulations, 2017 (hereinafter called 'the Regulations'), namely:-

- 1. Short Title and Commencement.- (1) These regulations may be called the Rajasthan Real Estate Regulatory Authority (Amendment) Regulations, 2019.
- (2) They shall come into force at once.
- 2. Amendment in clause 2 of the Regulations.- (1) In sub-clause
- (1), the existing item (ix) shall be substituted by the following, namely.-

- "(ix) "Registrar" means the Registrar of the Authority and shall include such other officer(s) of the Authority who may be authorized by the Chairperson to carry out any function under the Act or the Rules and for that purpose report directly to the Chairperson or a member."
- (2) In sub-clause (1), after the existing item (x), a new item (xi) shall be added, namely.-
 - "(xi) "RERA Account" means the separate account to be maintained by the promoter in a scheduled bank as per section $4(2)(\ell)(D)$ of the Act."
- 3. **Insertion of new clause 3A in the Regulations.-** After the existing clause 3 and before the existing clause 4, a new clause 3A shall be inserted, namely.-
 - "3A Changing RERA Account.- (1) The promoter may change the RERA Account from one Bank to another Bank only with the prior written permission of the Authority.



- (2) For seeking permission for changing RERA Account, promoter has to make written application in Form R-4A, along with the following documents:
 - Latest Account Statement / Copy of Passbook of the existing RERA Account;
 - Latest Account Statement / Copy of Passbook of the account proposed as new RERA Account; and
 - Copy of receipt of fee deposited for change of RERA
 Account.
- (3) After the RERA Account is permitted to be changed and has been changed, promoter is also required to submit the following documents:
 - a. Fund transfer compliance letter as per Form R-4B
 (Confirmation letter of change in RERA Account);
 - b. Form R-4C (Certificate from Bank having new RERA Account);
 - Form R-4D (Certificate of Chartered Accountant);
 and
 - d. Proof of old RERA Account closure.
