:: NOTIFICATION ::

In exercise of the power conferred by Section 92 read with Section 102 A of the Rajasthan Land Revenue Act, 1956, (Rajasthan Act No. 15 of 1956), in supersession of previous Notification dated April 20, 1961 and administrative orders issued from time to time, the State Government is hereby pleased to order that the Collector may, in exercise of the powers given to him by Section 92 of the said act, allot any Sawai chak or other Government Revenue land to the Urban Local Bodies Including JDA, UIT & Municipalities after charging the amount as shown in the table below, and place it at the disposal of the respective authorities, JDA, Urban Improvement Trust & Municipalities as shown below:-

Local Bodies	Amount to be charged
JDA, UITs A Grade Municipalities	40% of DLC land rate
B Grade Municipalities	30% of DLC land rate
C Grade Municipalities	20% of DLC land rate
D Grade Municipalities	10% of DLC land rate

Mutation in the name of Urban Local Bodies would be filled up and sanctioned and entries in the Jamabandies would be made only when the local bodies deposit complete amount to be charged as per above table in State Governments account.
